



Conflict of Interest Code for Members of the House of Commons

The Disclosure Statement is the initial document which a Member of the House must complete and file with the Office of the Conflict of Interest and Ethics Commissioner (CIEC) where the Member discloses his or her private interests as well as those of his or her family members. This information must be updated on a yearly basis.

From the information provided with the Disclosure Statement, the Commissioner is required to prepare a Disclosure Summary according to sections 23 and 24 of the Conflict of Interest Code for Members of the House of Commons. The Disclosure Summary is to be placed in the public registry which is available for public inspection during business hours.

Below are the various stages of the process for each file as of June 13, 2019.
