THE 2006 PUBLIC REGISTRY OF SPONSORED TRAVEL FOR MEMBERS

In 2006, there were a total of 69 instances of sponsored travel reported by 50 Members. An analysis indicates that:

- With 29 recorded activities, Taiwan, as in past years, remains the main destination of sponsored travel; these trips were sponsored primarily by the Chinese International Economic Cooperation Association (17 trips) and the Chinese Culture University (9 trips).
- Again, as in past years, Israel is the second most frequent destination, with 7 registered activities; 5 of these trips were sponsored by the Canada-Israel Committee.
- The duration of the sponsored trips ranged between one and ten days with seven days being the average length of a sponsored trip.
- Three Members account for over 25% of the sponsored travel. For these three members:
 - Honourable Irwin Cotler: Five different universities sponsored travel to attend and lecture at various international conferences with the remaining four of his trips sponsored by UN or non-governmental organizations.
 - Mr. John Williams: Of the four sponsored trips taken, two were sponsored by the Global Organization of Parliament against Corruption.
 - Mr. Byron Wilfert: Of the four trips, three were sponsored by Globe G8+5 International Dialogue with the remaining trip sponsored by the Global Legislators Organization for a Better Environment.

COMMENTS

As in previous years, I wish to remind Members of what constitutes sponsored travel according to the Members' Code. The definition can be found in section 15(1) which states; "*a trip that arise from or relates to his or her position, exceed \$500 and those costs are not wholly paid from the Consolidated Revenue Fund or by the Member personally, his or her political party or any interparliamentary association or friendship group recognized by the House.*" Therefore, only a small portion of the various kinds of travel in which Members take part fall within the definition of sponsored travel.

Indeed, travel which is part of a parliamentary business, paid out of any of Parliament's budget allocation is not considered as sponsored travel. For instance, the following travels do not need to be registered:

- travels of any parliamentary committee;
- any travels carried within the Interparliamentary Affairs of Parliament (i.e. within a parliamentary exchange program of either or both Speakers, with Interparliamentary associations or friendship groups as funded by the Joint Interparliamentary Council, etc...).

As well, travel and missions undertaken on behalf of the Canadian government and paid for by the Consolidated Revenue Fund (this would include, for instance, travels undertaken within a project of the Parliamentary Centre, if the project is funded either by CIDA or another federal government body).

I wish again to remind Members of the importance of carefully filling out the Sponsored Travel form and include all necessary information required by the Code. This indeed seems difficult for Members particularly in the area of determining the 'value' of the benefits received, as required by sub-section 2 of section 15 of the Code.

In addition, I hope to have a chance to discuss with the Standing committee on Procedure and House Affairs, within its current review of the Members' Conflict of Interest Code, the two outstanding issues already raised last year with respect to:

- How should we deal with the requirement to register travel which is 'not wholly paid' by Parliament or the Consolidated Revenue Fund? Are Members always aware of the source of all benefits associated with a specific trip?
- When a particular trip is sponsored by a private organization acting as an Executing Agency (such as for instance, the Parliamentary Centre or a Non-Government Organization-NGO) for a project sponsored and paid for, by the Canadian Government, should they be considered as paid by the Consolidated Revenue Fund or should they be registered as benefits and sponsored travels?

**PUBLIC STATEMENT OF SPONSORED TRAVEL BY MEMBERS
DÉCLARATION PUBLIQUE DE DÉPLACEMENTS PARRAINÉS**

15. (1) If travel costs of a Member for a trip that arises from or relates to his or her position exceed \$500 and those costs are not wholly paid from the Consolidated Revenue Fund or by the Member personally, his or her political party or any inter-parliamentary association or friendship group recognized by the House, the Member shall, **within 30 days after the end of the trip**, file a statement with the Ethics Commissioner disclosing the trip.

(2) The statement shall disclose the name of the person or organization paying for the trip, the name of any person accompanying the Member, the destination or destinations, the purpose and length of the trip, the nature of the benefits received and the value, including supporting documents for transportation and accommodation.

15. (1) Si les frais payables pour tout déplacement qu'il effectue dans le cadre de sa charge dépassent 500 \$ et ne sont pas entièrement pris en charge par le Trésor, par lui-même ou son parti, ou par un groupe d'amitié ou une association interparlementaire reconnu par la Chambre, le député dépose auprès du commissaire à l'éthique une déclaration faisant état du déplacement, **dans les trente jours qui en suivent la fin**.

(2) La déclaration comporte le nom de la personne ou de l'organisation qui prend en charge les frais de déplacement, le nom de toute personne accompagnant le député, la ou les destinations, le but et la durée du déplacement, la nature des avantages reçus et leur valeur, ainsi que des documents justificatifs pour les frais de transport et de logement.
